

**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AND PARENTAL CONSENT AGREEMENT (“AGREEMENT”)**

**ROSTER WAIVER**

-IN CONSIDERATION of being permitted to participate in any way in ODENTON SPORTS CENTER / SSM SPORTS LLC, ODENTON SPORT3S CENTER SPORTS LLC (“ODENTON SPORTS CENTER / SSM SPORTS LLC”) activities (“Activities”) I, for myself for personal representatives, assigns, heirs, and next of kin:
